## Don Whelan, Vice Chancellor for University Advancement

Don spoke about what the university is working on in regards to fundraising, what is next?

- There is a physical transformation of the campus emphasis.
- The last campaign for TCU ended in May 2012 raising over \$434 million over half was for facilities.
- \$100 million went to endowment.
- Fundraising: benefits and contributes to the TCU momentum
- New campaign started June 2012 with a 10 year timeline. It will be based on 3 years at a time
  - 1 \$150 million Foundation phase June 1, 2012 <ay 31, 2015 time to inform TCU community – to engage community
  - Funding Priorities: People and Programs
    - Scholarships
    - Faculty
    - Academic Programs
    - Facilities
  - Hoping this will be more heavily weighted towards programs/people (40-42%)
    - Alumni contribution is usually about 22%
    - Happy to inform that 78% of Faculty/Staff supports TCU
    - \$127.1 million raised so far from June 1, 2012 December 31, 2013
      - 26% Alumni contributed parents about 6%
  - 2016-2018 Leadership Gift Phase
  - 2019-2022 Public Phase Hope to raise about 40%
- The New Campaign for TCU they hope about 75% will go to Academic Programs and Faculty and 25% to Facilities
- Answering a question he indicated that 99% of the time donations are restricted to a particular cause
- The Neeley Business School has a \$100 Building Program

**Guest:** Steve and Jenny brought up the issue of Phishing and 2<sup>nd</sup> factor Authentication that will soon be part of TCU's enhanced internet security. For one month, emails were tracked and TCU received about 30 million emails, with increased phishing, all need to be aware of said dangers and what to look for. TCU will never send you a link to go back to TCU and enter your User name and password, nor personal ID. On November 20<sup>th</sup>, TCU will roll out the 2<sup>nd</sup> factor authentication for those who access TCU off campus or through other than VPN access. It will be required from Faculty, Staff, Retirees and Student employees who try to access employee services. At present, it will be done via cell phone (be sure to have your numbers updated on Employee Self-Service), you will receive a code to enter to have said access. Again it is only if accessing employee services when not on campus or not using VPN. Other options are in the works. More information is to follow via email, TCU Announce and Employee Self-Service.

There are over 200 people in residence at any given time at the Union Gospel Mission and these are much needed items. Drop off locations on campus are needed. Another project we will be doing which also benefits the Union Gospel Mission of Tarrant County is a toy Drive for their Toy Store. At present there are 43 children in residence, and the age group we will be providing toys for are the newborn-Age 3 group. They already have an Angel tree sponsor. The mission provides a Toy Store for parents to go and "purchase" up to 5 toys per child. Cindy reminded everyone about the Mattel Toy Store Outlet on Meacham Blvd, where TCU employees get 20% off regular prices and from the 1<sup>st</sup> to the 7<sup>th</sup> of every month the discount is 30% off. Collection for both drives will be through December 13<sup>th</sup>.
