Policy & Advocacy - Mica Bibb -

- Parking price increase resolution this will be shared with Faculty Senate and then go before the Cabinet since they accepted the pricing in the first place
- Has come through committee to Executive Committee, we're sharing with the full assembly and will send to Faculty Senate and ask for their support and then send to Cabinet and ask them to review and consider; hoping they will review it before the end of the semester
- Question was asked if there were any changes in the tiered lots and how they were to be determined; Adrian Andrews said nothing has been changed at this time
- Vanessa opinion Our role in Staff Assembly is to take in the information, collect data from our campus colleagues and go through all of it and come up with a decision. We are not experts in the specific details and it isn't our job to tell them how to do their job, but to give them information on how it affects the staff. The best recommendation was the cost structure.

Professional Development – Erin Wilson – no report

Old Business

- Covid update 8 active cases, recording of vaccinations has continued to increase; campaign with students trying to incentivize them to report - 51.4% students have reported they are vaccinated; 66.3% staff and 80.7% have reported they are vaccinated
 - Clinic last week in the BLUU for Covid shot, booster and Flu 173 given last week
 - Federal Executive Order that all federal contractors have to be vaccinated we at TCU have federal contracts, so that's something that we need to keep in mind.

We're listening to the experts in the area and Lee Tyner, General Counsel to the University.

- CDC Guidelines say workplace safety in an area where community that is high community spread, will probably drop to substantial within the next week or so, both of these categories are recommended by the CDC that masks be worn. This will probably remain the same for now.
- We are encouraging everyone to get vaccinated. If that executive order comes out we are figuring out how to handle this. There could be costs associated with this mandate.
- Health Center has vaccines and can go in Monday Friday 10:00 am 4:00 pm, can walk in and get vaccinated.
- Tulane got such a high level of vaccinations that they no longer have to wear masks, per CDC guidelines.

New Business
